4. I don't think I was ever asked if I wanted a court appointed attorney. I do not have one now as far as I know.
5. When I saw the judge for magistrate, the judge told me my charge and said my bond was set at \$25,000. I don't know why it is set at \$25,000. I cannot afford to pay the bond and so I am still in jail.
6. I don't remember the judge asking me any questions.
7. I do not know when I will get out or when I will be taken to court.
8. I am homeless and struggle to meet the basic necessities of life.



My name is Luis Miguel Westbrook. I attest that the following facts are true and correct to the best of my knowledge:

1. My name is Luis Miguel Westbrook and I am a 28 year old man.
2. On August 2, 2018, I was arrested for a misdemeanor offense and a felony offense.
3. On August 4, 2018, I was booked into the Dallas County Jail. When I got there, staff at the jail asked me questions about my finances. I told them that I don't have any income and that I am homeless. They asked what I could afford to pay for bail and I said I couldn't pay anything.
4. I was taken before a judge for magistration. My magistration only lasted about 60 seconds. The judge told me my bond was set at \$500 and \$1,300. The judge did not ask me any questions to the best of my knowledge.
5. I requested an attorney but as far as I know I haven't received one.
6. I do not know when I am getting out of jail or when I will be taken to court.
7. I am homeless and ~~as~~ I struggle to afford the basic necessities of life. I am in jail because I am unable to pay the bond.

My name is Roderick Moore and I attest to the following facts,

1. My name is Roderick Moore. I am a 41 yr old man.

2. I was arrested on Aug 3, 2018 for Poss. of a controlled substance and poss. of marijuana. The officers took me to the Dallas County Jail.

3. I was booked into the Dallas County Jail and after several hours was taken to see the Judge.

4. There were lots of people in the magistration hearing. I was told what I was arrested for and my bail was set at \$ 5000. No one ever asked me how much I could afford to pay to get out of jail. I don't remember filling out a financial form or being asked anything about my income.

5. I asked the Judge why my bail was set at \$ 5000. She said that \$ 5000 was the amount of money bail required for my charges. I tried to ask her why she set someone else's money bail at \$ 500 who

had the same charge. I was removed from the courtroom before the end of the docket.

I felt I was removed because I had asked questions. Later someone brought me the paperwork that listed my money bail amount.

6. I do not know when I will go to court or when I will get out of here.
7. My family is trying to get the money to bond me out, but we have bills to pay and it is hard.
8. To my knowledge I have not filled out any forms that detail my financial situation. I want to request a court appointed attorney but do not believe anyone has given me the paperwork.
9. I support my wife and 3 children. We struggle to meet the basic necessities of life.
10. I cannot afford the \$ 5000 money bail required for my release.

11 Being in jail means I am not working or taking care of my family. Being in jail makes me feel stressed out and its a mental challenge. I need to take care of my responsibilities and I can't in jail. I am worried I will lose my job.

4. When I got to the Dallas County jail 2 days later I was taken to booking & assigned housing. I filled out financial paperwork to request an attorney.
5. To my knowledge I have not been assigned an attorney. No one has told me when I have court or when I will get an attorney.
6. The Judge I saw did not ask me about my financial situation or if I could pay the bail amount.

7. I struggle to meet the basic necessities of life.
8. I cannot afford to pay the money bail required for my release.
9. I do not know when I will go to court or when I will get out of here.
10. Being in jail means I am not working or being with my family.

on the form. I signed the form because she told me to, not because I could afford to pay \$100 to buy my release from jail.

5. When I went into the courtroom, I was with lots of other people. The Judge set my bond at \$500. The Judge spoke to me for about 30 seconds. I don't know why she set my bond at \$500.
6. I do not know when I will go to court.
7. I have requested an attorney, but to my knowledge have not been assigned one and do not know when I will get one.
8. I struggle to meet the basic necessities of life. I am homeless and suffer from several physical ailments.
9. I cannot afford to pay the money bail required for my release.
10. I do not know when I will go to court or get out of here.

11. I plan to plead guilty and request time-served when I go to court so I can get out of jail as quickly as possible.
12. Being in jail means I can't try to find work or housing or take care of myself.

1. my name is Harriet Ogendi. I am a 25 year old woman.
2. I was arrested on August 4, 2018, early in the morning, for a misdemeanor offense. I was taken to the Dallas County jail.
3. I was given paperwork at the jail. The paperwork asked questions about my finances. I don't remember any one telling me what the paperwork was for. I filled out the forms and wrote that I was unemployed and a student.
4. Before I saw a judge, a woman asked me medical questions and asked if I'm worried about losing my job. I explained that I'm a student and don't have a job so I'm worried about school. I don't remember her asking me if I could afford to pay a bond.
5. When I was magistrated, the judge told me my bond was set at \$500. ~~The judge~~ To the best of my knowledge, the judge did not ask me any questions during magistration.
6. Some other inmates asked the judge why they didn't receive a personal bond; and the judge told them they didn't qualify. I did not bother asking because I didn't think it would help.
7. To the best of my knowledge, I do not have an attorney yet despite requesting one.
8. I do not know when I will get out of jail. I have class today and am worried about school. I have assignments due and I am missing finals.

9. I have a bank account and I think I may have enough money to pay the bail amount, but I don't have my debit card with me. I also don't have my phone so I can't call my family or friends to ask for help because I haven't memorized their numbers. I have to stay in jail because I don't have access to the money I need to get out.
10. I don't have any idea when I will be taken to court.
