We would like to invite you to participate in this process by providing responses to the questions asked on the next page.

Please help educate voters in your district by providing your full response by August 22, 2018.

For incumbent legislators we ask you to provide a short candidate statement highlighting your reasons for seeking office in this district and a brief listing of your top 3 priorities in the next legislative session. Please limit your candidate statement to 500-words and limit top priorities to 250-words per priority.

In addition, we will be providing information regarding incumbent voting records on legislation of key importance to the ACLU of Texas and our membership in the 2017 regular and 2017 special sessions. This information will be presented to members and other voters as a total percentage score based on how the incumbent voted.

For non-incumbent candidates we ask you to provide a short candidate statement highlighting your reasons for seeking office in this district and a brief listing of your top 3 priorities in the next legislative session. Please limit your candidate statement to 500-words and limit top priorities to 250-words per priority.

In addition, we will be asking you to take a position for or against legislation of key importance to the ACLU of Texas and our membership in the 2017 regular and 2017 special sessions.

<u>Legislation has been divided into 3 categories:</u>

- Ending Discrimination: positions on LGBTQ equality, immigrant rights and reproductive freedom
- Advancing Justice: positions on criminal justice reform
- Protecting Liberty: positions on free speech

Rhetta Bowers is proud and dedicated wife of a Gulf War Veteran, a mother and democrat committed to changing her community for the better.

Rhetta followed their courageous examples of community engagement. Her own life of activism began when she volunteered to phone bank for the late Congressman Mickey Leland as a pre-teen, later worked on her own mother's campaign and quest for the Texas House and she hasn't stopped since.

As an educator, a PTA member, and through her volunteer work with the Garland Independent School District, Rhetta has learned the value of investing in young people. She was appointed to the Rowlett Parks and Recreation Advisory Board and served for 8 years. She has a proven record of working with community leaders in the City of Rowlett, as well as leaders with the City of Dallas and other municipalities. She looks forward to serving the North Texas community in which she and her husband have raised their children.

As a former broadcast journalist, educator and a full-time wife and mother, she knows from experience that the path to success is founded upon hard work, access to education, job opportunity, and quality healthcare. She ran for State House in 2016 and is running again in 2018 because of her commitment to ensuring that every Texan gets a fair shot.

In January of 2017 and 2018, Rhetta Chaired the Dallas Women's March, an empowering and positive March that has drawn thousands of participants each year. She is the recipient of the 2017 Community Service Award from the Garland Chapter of the National Association of Negro Business and Professional



Women's Club, the 2017 *Rising Star* Award from the Dallas Alumni Chapter of her alma mater, Texas Southern University, and a 2017 *Spelman Woman to Watch*, among other accolades. Rhetta is a faithful and active member of St. Paul United Methodist Church and a lifetime member of Delta Sigma Theta Sorority, Inc.

We will include links to the bill language for each piece of legislation.

To respond just select FOR or AGAINST or ABSTAIN for each piece of legislation to reflect how you would have voted given the opportunity. Your answers will be used to create an overall score on your position on ACLU of Texas key issues.

Section I - Ending Discrimination

Description – Legislation pertaining to LGBTQ equality, immigrant rights and reproductive freedom.

Senate Bill 4

Relating to the enforcement by campus police departments and certain local government entities of state and federal laws governing immigration and to related duties and liability of certain persons in the criminal justice system; providing a civil penalty; creating a criminal offense.

Senate Bill 8

Relating to certain prohibited abortions and the treatment and disposition of a human fetus, human fetal tissue, and embryonic and fetal tissue remains; creating a civil cause of action; imposing a civil penalty; creating criminal offenses.

House Bill 3859

Relating to protection of the rights of conscience for child welfare services providers.

House Bill 13 – Special Session

Relating to reporting requirements by certain physicians and health care facilities for abortion complications; authorizing a civil penalty.

Relating to health plan and health benefit plan coverage for elective abortion.

Relating to reporting and certification requirements by certain physicians regarding certain abortions.

Section II - Advancing Justice

Description – Legislation pertaining to reforming our criminal justice system.

House Bill 351

Relating to the administrative, civil, and criminal consequences, including fines, fees, and costs, imposed on persons arrested for, charged with, or convicted of certain criminal offenses and to the creation of a commission to review certain penal laws of this state; increasing a criminal penalty.

House Bill 3130

Relating to the establishment of an educational and vocational training pilot program for certain state jail felony defendants.

Senate Bill 292

Relating to the creation of grant programs to reduce recidivism, arrest, and incarceration of individuals with mental illness.

Senate Bill 1849

Relating to interactions between law enforcement and individuals detained or arrested on suspicion of the commission of criminal offenses, to the confinement, conviction, or release of those individuals, and to grants supporting populations that are more likely to interact frequently with law enforcement.

House Bill 674

Relating to the suspension of a student enrolled in a grade level below grade three from public school and to a positive behavior program for public schools.

Description – Legislation pertaining to free speech.

House Bill 89

Relating to state contracts with and investments in companies that boycott Israel.

Senate Bill 179

Relating to harassment, bullying, and cyberbullying of a public school student or minor and certain mental health programs for public school students; increasing a criminal penalty.
