Other Programs - Voting Rights seeks to protect every Texan's legal right to vote in local, statewide, and national elections conducted in the State of Texas. Voter suppression laws have existed for decades prior to the Voting Rights Act of 1964 and continue in the State of Texas to this day. The objectives are to (1) ensure laws designed to suppress voter registration and voter turnout do not pass in the state legislature by educating and informing Texans of their legal rights to vote, and (2) mobilize Texans to advocate in their communities while also monitoring elections via hotlines and poll watchers to ensure voting rights are not violated during the election process.

Immigrant Rights - This program focuses on the federal policing abuses seen on the 1200 miles of border with Mexico, from El Paso to Brownsville. In the past year, ACLU of Texas has hosted 27 Congressional delegations at various locations on the Texas border to make them aware of the abuses of migrants as well as legal Texas residents by federal, state, & local law enforcement agencies. ACLU of Texas has conducted public awareness campaigns along the border and the Customs and Border Patrol checkpoints in addition to organizing and leading rallies and protests at ports of entry along the border.

We do our work in the "public square" as well as leveraging our policy expertise, community and volunteer engagement, and strategic communications to affect change in legislative bodies such as the state legislature, city councils, school boards and county commissions.

Form 990, Part III, Line 4a - Program Service Accomplishments

Criminal Law Reform - The ACLU of Texas has seen many successes in this area at both the local and state levels. In Dallas, we have seen reforms such as:

- No prosecution on misdemeanor possession of marijuana cases, as well as State Jail Felony and 3rd Degree Felony Possession of THC for first-time offenders whose offenses do not occur in a drug-free zone, involve the use or exhibition of a deadly weapon, or involve evidence of delivery.
- Dismissed all pending misdemeanor marijuana cases filed before the new District Attorney took office.
- No person will be prosecuted in Dallas County for possessing less than .01 grams of drug "trace" evidence.

At the state level, the ACLU of Texas had significant achievements in the Texas legislative session. Working with our partners, we finally brought to an end the Driver Responsibility Program, which made traffic violations multi-thousand dollar crimes, leading to the incarceration of poor Texans who were unable to pay their fines and fees.

Abortion Rights - The ACLU of Texas seeks to protect women's rights and access to a safe, legal abortion. It includes protecting and expanding legal safeguards of women's reproductive autonomy through litigation and public policy. We are working to build a wall at the local level against infringements on Roe v Wade: many Texas communities are attempting to enact ordinances that would criminalize providers and patients who provide or obtain abortions. Our work focuses on mobilizing volunteers and other grassroots activists to speak up and speak out.

The organization has members who pay annual dues. A Texas resident who is a member in good standing with the National ACLU organization is thereby a member of ACLU of Texas. Members elect the local Board of Directors annually for staggered, three-year terms with one third of the positions to be filled each year. Twenty-four Directors are elected by the membership and up to six may be elected by the Board of Directors. All members of the Board of Directors are elected at-large. Directors elected by the members are elected by mail ballot pursuant to such rules as the Board of Directors may adopt. At its next meeting following the election, the Board of Directors canvasses the results of the election and, if necessary to provide an adequate level of diversity, may elect to the board up to six additional Directors as soon as practicable after each election cycle.

The Personnel Committee makes a compensation recommendation to the Board based on an annual salary survey of 53 ACLU organizations plus a survey of Executive Director salaries of similar organizations in similar locations. The Board then discusses the recommended compensation, deliberates and votes on approval.
